a. ELPAC Initial assessments have started up.

- i. With the state of California now updating TOMS for all Schools, Pathways Academy has started its process for bringing in all identified EL students without a prior ELPAC score for the state.
- b. IXL Diagnostic Tool introduction into the school environment.
 - i. IXL is an educational suite of tools for allowing schools to generate student educational benchmarks to better enable targeted instruction to fill instruction gaps. It also includes customized lesson plans and a library of lessons meant to better help student instruction.
- c. How can IXL impact our outcomes in the state assessments?
 - i. IXL's diagnostic being modeled after the California Common Core Standards means the areas of need identified for each student will allow us to target those gaps in a student's education.
