Pathways Academy is an accredited, online high school for students 16 and older authorized by the Warner Unified School District. It offers a flexible, personalized, and self-paced learning environment using the Edgenuity curriculum, with students able to access coursework 24/7 and receive support from highly qualified teachers and counselors through live virtual meetings. The program includes college and career counseling and leads to a high school diploma.

 - Edgenuity is the online curriculum program, 0% students lacking access to online curriculum.

VI. Tiered Reengagement Overview

- Pathways adheres to the CDE' guidelines for offering intervention for students who are not meeting attendance requirements.
- Students can be put on a Tiered Reengagement Plan due to not meeting any of the following: minimum lesson requirements (10/week for YASA and 5/week for Adult); daily login requirement; mandatory Homeroom attendance (YASA)
- Each week that a student does not meet requirements, they progress from Tier 1 to Tier 5
- If the student does not re-engage and meet the requirements, they are ultimately involuntarily withdrawn
- Students who are withdrawn are able to return and re-enroll after a 30-day waiting period
